took place at the Omaha National Cemetery on 15 Dec 2018. Compatriots Ryan Fuller, Ben Harvey, Paul Burright, and Mel Burright were part of the volunteer crew to help direct and seat family members of veterans buried at the cemetery to ensure they were the first to be able to receive wreaths to place on their loved ones headstone.

The ceremony took place at the flag assembly area with a presentation of the colors by the American Legion Millard Post 374 and Millard South JROTC. There was a short welcome and blessing of the wreaths and presentation of wreaths for all branches of service. Omaha native, Sgt Maj Dean Vance, veteran of Operation Desert Shield, was the guest speaker. There was a 3-Volley Salute

followed by the playing of TAPS. The colors were retired and the public was released to lay wreaths on the headstones of the veterans.

The Battle of Trenton happened on 26 Dec 1776. The American Army had been defeated and lost the Battle of Long Island earlier that year. Dejected, General Washington vowed to turn around their fortunes.

Hessian forces were camped in Trenton, New Jersey, and General Washington devised a plan with his commanding Generals to take Trenton back from the Hessians and improve the army's spirits.

The Delaware River was already freezing over and had ice floes, but it was the only way to get across without detection by the British. The plan was to cross the river at 3 points: 1 with a Rhode Island regiment accompanied by Pennsylvania and Delaware troops, a 2nd under Brig Gen Ewing, and a

third led by Washington himself along with Maj Gen Nathaniel Greene and John Sullivan. They did this on Christmas night 1776.

The thought was that the Hessians would be celebrating their

traditional German festivities and be drunk, thus making it easier to take the city back.

The cold and snow and the crossing of the freezing river, made the march very difficult for the Americans. When Gen Sullivan wrote to Washington about the gun powder getting wet, Washington replied firmly, "Tell General Sullivan to use the bayonet. I am resolved to take Trenton." Halfway to Trenton, the army met up with another American force led by Adam Stephen, and the Americans began to build their confidence. As the troops marched down Pennington Road, Washington sent out an advance of troops to a Hessian outpost in a copper shop.

The battle began when a German, Lt.

Andreas von Wiederholt came out of the copper shop for some fresh air and was immediately shot at by American troops. The Hessians began to retreat. Washington knew he had to cut off all means of retreat and disbanded some of the men from the main force and sent them near Princeton. General Sullivan stationed his men near Assunpink Creek. As the fighting intensified, the Hessians tried to regroup in the major streets of Trenton, but the Americans took them head on, and the Hessians began to retreat, as they realized they had miscalculated the force they were engaged with. Greene and Sullivan positioned their troops to block off all means of escape from Trenton, and troops began going house to house to find hiding German soldiers. General Sullivan's troops opened fire on the remaining Hessians trying to mount one last defense, under the command of Col. Rall. The German Colonel was shot and the Hessians scattered in all directions and surrendered.

The victory bolstered the American's spirits after a string of defeats early in the war.

OMAHA PATRIOT MUSTER!

The initial Patriot Muster for the Omaha Chapter was a great success. We had a good turnout and saw a few Compatriots that we have not seen in a while, which was great!

The night began as normal, with the SAR pledge and reading of officers reports. After dinner, Secretary Paul Burright provided a short program on a Chapter year in review for 2018, highlighting our accomplishments, new members added, our growing Color Guard, our great programs that we heard throughout the year, and recognizing some of our fallen Compatriots.

We then moved on to some Chapter recognition. We recognized our 5 and 10 year members, then awarded Bob Knott a 15 year member pin and certificate, and John Parsons a 20 year member pin and certificate. We recognized those that had supplemental applications approved in 2018, and Presi-

dent Tom Upton presented Compatriot Ryan Fuller with the Chapter Distinguished Service Medal for his contributions to our Chapter's success.

After the celebration of the 2018 year, we moved on to celebrating our Patriots, by each current member in attendance, listing their Patriot, by State of service, in our new Chapter Muster Log Book.


