Omaha Compatriots,

We have put this call out before, but did not have much emphasis or intensity behind it. When the idea for this program first came about, and the first call to help out with this program was given, we had no one in the pipeline as far as applications were concerned. That has changed dramatically in the past couple of months.

Currently, we have 7 new applications listed on the Application Status Report, and we should have 3–4 more, that should show up on the report in the coming weeks, and 5 more in the process of being completed. THIS MONTH IN THE REVOLUTION

The Second Continental Congress convened on 10 May 1775, and would govern the colonies and remain in session the entire war.

The first Continental Congress had convened the prior year and tried to get some relief from the King and the Intolerable Acts, but were unsuccessful. Many were outraged due to the Coercive Acts and believed it was time to take up arms against the Crown, and the Continental Congress then reconvened to address the topics of contention.

The discussions of this Second Congress were much different than the first. In the First Congress, discussions were about reconciliation and working with the Crown on their disagreements. The discussions of the Second



Congress revolved around war. They voted to form a Continental Army with George Washington in command as General of the Army. There was much to discuss on how to man, equip, and outfit this new army, and be able to fight a war, with no means to do so.

A call for volunteers to sign up for 1 year was put out to the colonists and that is how the Continental Army was first formed. They also took donations, from those loyal to the Patriot Cause, to help outfit and equip this new Army.

The Congress also formed a foreign rela-

tions delegation to continue to politically navigate a peace with the King. Many at this point still desired to be a part of the British Empire and be loyal to the Crown. The Congress sent the delegation with the "Olive Branch Petition", seeking to have their disagreements heard and addressed by the Crown, but still remain faithful and loyal British subjects.

The "Olive Branch Petition" was ignored by King George, and the Crown sent reinforcements of troops and Hessian mercenaries to suppress the rebellious colonists. At this point, notions of kinship and friendships were set aside and Congress was all in on war and Independence from Britain. The following year, in July, a formal Declaration of Independence was drawn up and signed by every delegate in Congress.

The Bronze ROTC Medal is given to JROTC cadets who foster the principle of the "citizen soldier", exemplified by the Minuteman, and are chosen by . their commanding officer based on leadership qualities, military bearing, • and general excellence. The cadet must also be currently enrolled in the JROTC program, should be a 3rd year • cadet in a 4 year program, must be in the top 10% of their JROTC class, must be in the top 25% of their overall class, and the cadet may not have received the Bronze SAR medal previously.

The Silver ROTC Medal is given to • ROTC cadets who are currently enrolled in a College or University ROTC program and foster the principle of the "citizen soldier", exemplified by the Minuteman, and are chosen by their commanding officer based on their military bearing, leadership potential, attitude, scholastic achievement, and general excellence. The commanding officer has complete latitude on who they select to receive the SAR medal.

MAY MEETING PROGRAM & NOTES

Our May meeting was full of good information and another great program.

The Color Guard will be participating in the Purple Heart Honor Flight on Friday, May 24 in Omaha. They will also be participating in the Memorial Day Ceremony at the Omaha National Cemetery on May 27.

The Omaha Chapter will have a new elected office for the next election cycle. Chapter Registrars were approved at the Spring State Meeting.

We will be have a Chapter outing on Sat, Jun 22. We will have lunch at The Rustic Inn in Fort Calhoun and after lunch, a tour of Fort Atkinson.

Larry Jacobsen, a member of the Board of Directors for Prospect Hill Cemetery, gave a very informative program on "The History of Prospect Hill".

Prospect Hill Cemetery spans 160 years of Omaha history, from 1858— Present. Omaha was founded in 1854, and there were some cemeteries around town that popped up, but no major public cemeteries until Prospect Hill.

Jesse Lowe, had rights to the southern section of land around 30th and Parker, and planned to form Cedar Hills Cemetery. Moses Shinn, owned the northern section of land, around the current cemetery, and planned to form Omaha City Cemetery. Byron Reed owned a section of property between the north and south sections and wanted to form his own cemetery.

Other business prospects caused Jesse Lowe to sell off his land to the south, and Byron Reed purchased it. Moses Shinn passed away and Byron Reed ended up purchasing his Moses Shinn's land from his surviving sons. This now incorporated the current plot of Prospect Hill Cemetery and Prospect Hill was formed in 1865, as the first public cemetery in Omaha.

Omaha resident, Alonzo F. Salisbury (1808-1858) is listed in records as burial permit #1. Improvements were made to the property and a custodian house was



built in 1918. Over the years, even though many prominent Omaha residents were entombed at the cemetery, it became run down and very unkempt. Vandalism was a big issue in the mid to late 20th Century. New ownership and volunteers began to clean up the cemetery and restore many of the headstones and monuments, and it now hosts many public tours and a very large Memorial Day Ceremony. Many prominent Omaha residents are buried within the grounds, including our first Nebraska SAR President, Champion Chase.
