CHAPTER REGISTRAR

As of this coming Chapter election cycle, we will now add the Chapter Registrar to the elected offices of the Chapter. We are currently looking for someone to fill this role, so that we have 1 Compatriot per elected office and it either does not remain open, or someone doesn't have to pull double duty, covering two offices. That is what we are currently facing.

The Chapter Registrar position, would work with the State Registrar and State Secretary, to ensure that applications, both new member and supplemental, are complete and ready to be sent to National for adjudication.

As Chapter Registrar, you would be the point of contact

for potential new members, as you get notification of their inquiry into membership online, or are notified from other members, who are recruiting, of potential new members, and help them through the application process. This should help our numbers grow, as those applications would strictly be for the Chapter, and would not get bogged down with all the other applications for the State.

Your duties would include ensuring that all information is correct on the application, collect all proofs from the applicant, for each generation, ensuring they are all tangible, lineage based proof back to the Patriot, and prepare the packet of proofs and signed

application, to be sent to the State officers for inspection prior to them sending apps to National.

This is an important position to fill, and we really need one of you to step up and fill this role for the Chapter. If you have interest in this new endeavor, please contact one of the nominating committee, Bob Knott, Bill Webb, or David Kentsmith. Secretary, Paul Burright, will also be able to mentor you in this new role, as he has effectively been the de-facto Registrar, helping with Chapter applications for the State officers, this past year. Resources are available to help you succeed as a Registrar. Please consider taking on the duties of this new role! Huzzah!

THIS MONTH IN THE REVOLUTION

30 Oct 1775—The Continental Congress establishes the Naval Committee.

The Continental Congress appoints seven members to serve on an administrative naval committee tasked with the acquisition, outfit-

ting and manning of a naval fleet to be used in defense against the British. Almost two weeks earlier, on October 13, 1775, Congress had authorized the construction and arming of vessels for the country's first navy.

Members of the first naval committee included some of the most influential members

of the Continental Congress and several "founding fathers," including John Adams, Joseph Hewes, John Langdon, Richard Henry Lee, Silas Deane and Stephen Hopkins, the committee's chairman. On December 22, Esek Hopkins, Stephen's brother, was appointed the first commander in chief of the Continental Navy. Congress also named four captains to the new service: Dudley Saltonstall, Abraham Whipple, Nicholas Biddle and John Burrows Hopkins. (The Nebras-



ka SAR's 1st Place Eagle Scout Essay winner, wrote his essay on one of these early Captains, Abraham Whipple.) Their respective vessels, the 24-gun frigates Alfred and Columbus, and the 14-gun brigs Andrew Doria and Cabot, as well as three schooners, the Hornet, the

Wasp and the Fly, became the first ships of the Navy's fleet. Five first lieutenants, including future American hero John Paul Jones, five second lieutenants and three third lieutenants also received their commissions.

With help from the committee, Ameri-

ca's first navy went from a fleet of two vessels on the day Congress established the naval committee to a fleet of more than 40 armed ships and vessels at the height of the War for Independence. The Continental Navy successfully preyed upon British merchant shipping and won several victories over British warships. This first naval

force was disbanded after the war. What is now known as the United States Navy was formally established with the creation of the federal Department of the Navy in April 1798.

OCT MEETING PROGRAM & NOTES

Our meeting for October was held on 08 Oct 2019 at Gorat's Steakhouse.

Compatriots in attendance celebrated Compatriot Fred Walden's birthday with congratulations and a picture!



Other business items were tabled for the November meeting, with Compatriots being honored, not in attendance.

Our program for the evening was "150 Architectural Buildings in Nebraska", by Jeff Barnes. Jeff is a freelance writer, who wrote the book his program is based on, during Nebraska's 150th Anniversary, in 2017.

The book chronicles some of Nebraska's more unique architecture, including Bellevue's log house, built in the 1830's, making it Nebraska's oldest surviving building.

He also described our oldest brick building—the Bank of Florence building, built in 1857.

Gothenburg has the Midway Station from the 1850's, which served as a Pony Express Station, and a fur trading post.

Nebraska also has many unique County Courthouses. Many counties put a lot of money into their courthouses to attract settlers, but none cost as much as the Lincoln County Courthouse in North Platte, built in the 1920's, at a final cost of \$10,000,000. It remains the most expensive, and longest construction time project, of any of the Nebraska Courthouses. The Otoe County Courthouse was built in 1864 and is the oldest public building in the State.

Many unique houses of worship were also built in Nebraska. The oldest is the 1st Presbyterian Church in Bellevue, which was built in 1858. There is also the Regimental Chapel, in Lincoln. Its construction was influenced by Eleanor Roosevelt, who felt the nation needed Chapels for our troops heading off to WWII. It is one of the few remaining Regimental Chapels in the country.

Noted Nebraskans who have homes in Nebraska: J. Sterling Morton's Arbor Lodge in Nebraska City, Father Flanagan's home in Boys Town, William Jennings Bryan's Fairview home in Lincoln, Willa Cather's home in Red Cloud, and Buffalo Bill's home in North Platte. Thomas Rogers Kimball was Omaha's most famous architect, responsible for the Omaha Public Library, Burlington Station, and St. Cecilia's Cathedral. The original columns used in the original Burlington Station, are now outside Memorial Stadium at the University of Nebraska.

The Omaha Building, aka the New York Life Building was also discussed for its unique design. Of course, the Nebraska SAR began in the New York Life building in Omaha.

It was a very informative program, and we appreciate Jeff Barnes for presenting us with these great Nebraska buildings.
