



## **Revolutionary History**

#### **Boston Tea Party**

On 16 Dec 1773, members of the Sons of Liberty in Boston, Massachusetts, some dressed as Native Americans, protested the Tea Act of 10 May 1773. The Tea Act allowed the British East India Company to sell tea from China, to the Colonies, without paying any taxes, other than those imposed by the Townshend Acts. The protest ended up destroying an entire shipment, when the Sons of Liberty, led by Samuel Adams, threw an entire shipment of tea into the harbor.

At the end of the French and Indian War, the Crown was deep in debt. Parliament began to levy taxes on the colonies to help pay down the debt of the long wars with France. The colonists had no representation in Parliament, and this was the root of the anger the colonists' had toward these new taxes. Colonists believed that since they did not elect representatives to Parliament, that Parliament could not levy taxes against them, per the British Constitution. The colonies believed that the only governmental bodies that could levy taxes on them, were their own local colonial assemblies.

Parliament started with the Stamp Act, to try to garner revenue from the colonies, but major protests caused that Act to be repealed in 1766. In 1766, however, Britain passed the Declaratory Act, which said that Britain had the "right to legislate for the colonies, in all cases, whatsoever."

1767, the Townshend Acts were passed, to levy more taxes on the colonies.

Tea from the Dutch was being smuggled into many areas of the British Empire, as it could be had for much cheaper prices due to no taxes being levied by the Dutch. This caused major operating losses for the British East India Company, as the Dutch tea was so much cheaper. The colonies continued to protest and in 1770, Parliament finally repealed the

Townshend Acts, except for the tea duty, which Prime Minister, Lord North, kept to assert "the right of taxing the Americans".

The Tea Act was instituted in 1773, as a way to help prop up the East India Company. It gave the British company a refund on the Townshend tea taxes that the company would normally have to pay to export tea to Great Britain. It also allowed them to directly re-export that tea to the American colonies, instead of using a wholesale buyer. They were able to set up consigners for the tea in the major ports, who sold the tea on commission. This essentially gave the East India Company a monopoly on tea, and had the hidden purpose of ensuring that the colonies paid the 3 pence per pound Townshend duty on tea. With the refund, they were even able to undercut the price of tea against the legal colonial importers that paid the tax, but did not get the refund from the government. The EIC, knowing that the tax issue was a sensitive one, tried to make arrangements to keep the tax refunds quiet, in various ways, but they were unsuccessful.

As protests over the Tea Act began to build, the price of tea actually dropped, but the familiar "no taxation without representation" and Parliament's actual authority over the colonies was at the forefront. Samuel Adams considered the British tea monopoly to be "equal to a tax", and some regarded the tax program as a dangerous infringement of colonial rights.

This was especially true in Massachusetts, the only colony that the Townshend Acts were fully enforced, due to the prior protests there.

In every colony, except Massachusetts, protestors were able to get consignees to resign or send the tea back to England. In Boston, however, the Governor was determined to stand his ground. When the tea ship *Dartmouth* arrived in Boston Harbor, in late November, Samuel Adams called for a mass meeting to be held at Faneuil Hall, on 29 Nov 1773. So many people showed up, the meeting had to be moved to the larger Old South Meeting House. British law required the Dartmouth to unload and pay the duties within 20 days. The meeting passed a resolution to urge the Captain to go back to England with his cargo, as had happened in other ports. It also assigned 25 men to watch over the ship and ensure it didn't unload its contents. The Governor would not allow the ship to leave port, and on 16 Dec, the last day for Dartmouth's deadline, Adams called for another meeting. The meeting's attendance was roughly 5000-7000, out of a town of 16,000. The meeting got out of hand, and people left the meeting before it ended, determined to take some Some 30-150 men, some disguised as Mohawk warriors, boarded the 3 ships in port, and over a span of 3 hours, dumped 342 chests of tea, worth approximately \$1.7 million in today's currency, into the waters of the harbor. It is in dispute whether Samuel Adams actually had any part in planning the Boston Tea Party, but after it occurred,

> he went right to work to publicize and defend it. He argued that the Tea Party was not the act of a lawless mob. but was instead a principled protest, and the only remaining option the people had in defending their constitutional rights. Britain responded by closing the port of Boston, and issuing the Intolerable Acts, which in turn caused for the calling of the First Continental Congress in 1774, to try to reconcile with the British Crown.

## DAR Monument Dedication Omaha National Cemetery

On Friday afternoon, 01 Nov 2019, the Nebraska SAR Color Guard presented the colors, at a ceremony dedicating a monument installed by the DAR, at Omaha National Cemetery.

The ceremony was a culmination of 3 years of work by the DAR, beginning when the Omaha National Cemetery was opened in 2016. The monument is dedicated to all members of the armed forces who have served our country, for all wars, going back to the Revolution. *Pictured* below L-R Lincoln Color Guard Captain Shawn Stoner, Omaha Color Guard Captain Paul Burright, and Color Guard Compatriots Tom Upton, Jim Sly, and Ron Stites, all participated in the honor guard for this ceremony. The ceremony began at the stage, in the middle of the cemetery, then the Color Guard led those in attendance down to the monument, for the dedication and unveiling of the monument.

It was an honor for the Color Guard to be of service for this event, and they hope to support our sisters in the DAR at more events in the future.

## President General's Proclamation

On Saturday, Dec. 14, the nation will honor our fallen heroes with acts of remembrance at Arlington National Cemetery and over 1900 veteran cemeteries. What began as a patriotic act by Maine businessman Morrill Worcester in 1992, is now nationally recognized as the Wreaths Across America program. Formally recognized by the United States Congress in 2008, its mission is to REMEM-BER, HONOR and TEACH. To honor veterans during the holiday season, a remembrance wreath is laid by volunteers upon the hero's grave in every state, at sea, and abroad.

Wreaths Across America works with thousands of schools, scout, and civic groups, including the SAR's Patriotic Outreach Committee, to secure An "Honor wreath sponsorships. Fleet" comprised of over 170 trucking companies, donate their trucks that are driven by volunteer drivers called "rolling ambassadors" to identified cemeteries. This year, eleven tractor trailers will transport 283,000 sponsored wreaths to Arlington National Cemetery and other designated veterans cemeteries. These "truckloads of respect" travel from Herrington, Maine to Arlington National Cemetery filled with sponsored wreaths in what is known as the world's largest veteran's parade.

President of American Gold Star Mothers, Inc., Mona Gunn, will be the 2019 Grand Marshal of this annual escort to Arlington National Cemetery. The parade's theme will REMEMBER, HONOR, and TEACH with public events scheduled in Maine, Massachusetts, Connecticut, New Jersey, Delaware, Maryland, and Washington D.C.

This year, for the first time, the Omaha Chapter became a fundraising group for Wreaths Across Ameri-The Omaha Chapter, and the Nebraska SAR, has always been a supporter of the event, both financially and volunteer support, the Omaha Chapter decided to go further and gain some support from our community in getting wreath sponsorships. They were able to get 73 wreath sponsorships through our donation website. While that fell short of the goal, they were excited to be part of the program, and will take what was learned this year, and make the program even better. They work toward hitting their Chapter sponsorship goal, next year.

The Omaha Chapter also, as had been done the past few years, donated financially, directly to the Wreaths Across America event, held at Omaha National Cemetery.

## Fall Leadership Meeting Report

My first event was the Council of VPG's meeting on Friday morning. The representatives of the various districts were encouraged to promote member retention, reinstatement, and mentorship. We were informed that one of the most effective ways to increase retention is to have a national level dues program, in which there is an option for automatic dues renewal. While the idea is being actively pursued by National, it is acknowledged that it will take some time to implement, as there is currently a wide variance among states and chapters as to how

On Friday afternoon, there was a tour of the National Headquarters for first-time attendees. In addition to seeing staff offices and the library, we saw the first floor museum space, where the proposed layout of each display was marked with tape on the floor. That evening, I had the honor of participating with the color guard in posting the colors for the banquet. An informative update was given by a representative from Solid Light, Inc. on the progress of the SAR Education Center and Museum (see www.sarfoundation.org for more information).

dues are handled.

On Saturday morning, I attended the donor recognition breakfast and the Trustee meeting. Some of the items of business conducted at the Trustee meeting included:

1. The contract with Solid Light, Inc. was amended to add a retail store to the museum plans at no additional

cost.

- 2. \$2,400 in the U.S. Stamp Fund was reallocated to the 250th Anniversary Fund.
- 3. \$10,000 in the King's College Project Fund was reallocated to continuing the upgrade of the accounting software and a new storefront.
- 4. \$38,500 was allocated to the remaining work on the membership data module. The new membership database should be on-line by the Spring leadership meeting.
- 5. The proposed 2020 budget was approved.
- 6. Donations to the George Washington Endowment Fund will be split evenly between the George Washington Endowment Fund, the Howard F. Horne, Jr. Fund, and the Walter Buchanan "Buck" Meek Fund to build up the amount of money in these funds.
- 7. The 2024 National Congress will be held in Pennsylvania.
- 8. Five donated swords found to be from the 1800's or later will be sold at auction, with the proceeds going to the museum special artifacts fund.

On Saturday evening, there was a banquet where we saw an interesting presentation on Bermuda and the American Revolution and learned about the upcoming SAR/DAR/CAR Bermuda trip planned for May 13-18, 2020. I joined the "SARpremes" in singing a few Revolutionary War era songs at the banquet, as well as a version of the famous Kingston Trio song "M.T.A." in honor of Massachusetts resident and President General, Jack Manning. Finally, I participated with the color guard in retiring the colors.

#### Commendation Letter, on behalf of Lt. Levi Krause, 2019 SAR Law Enforcement Medal Recipient



Dear Sir:

It is a pleasure and honor to provide you with a brief summary of Lieutenant Levi Krause's career as a Nebraska Conservation Officer. Your consideration in selecting this Officer to receive this prestigious award could not be more deserving and appropriate.

Back in 1980, roughly 39 years ago, Levi Krause began his career as a Conservation Officer. In 2012, he was promoted to a District supervisor position, and is a past recipient of the Shikar Safari Award. His distinguished career is highlighted by his ongoing devotion to public safety, leadership, and reliable service to the public. Unfortunately, Levi is currently enjoying a well deserved retirement. There are a number of unique factors making the Conservation Officer duties more than a little different, which are often overlooked and taken for granted without appreciating the impact on the entire family. I can assure you that maintaining an office in your home, living out of a truck, being responsible for multiple counties and feeling the pressure of providing a 24/7, 365 service to the public, can take a toll on the officer. Unfortunately, their spouse and family have to deal with their irregular schedules, persistent phone calls and being gone on weekends, nights, and holidays. Because of this, it's very appropriate that Levi's wife, Julie, is here. Without her ongoing tolerance and uncompromising support, Levi could not have accomplished all that he did.

During the recent flooding event in eastern Nebraska, Lieutenant Levi Krause's performance was excessively beyond the call of duty. In a few short days, Levi logged over 80 hours and drove over a thousand road miles while rescuing 65 people in an air-He reunited families, pulled mothers and children from their flooded homes, evacuated day care centers, delivered medicine, and rescued other first responders who had become stranded. To give you a visual image of what this was like, close your eyes because many of his efforts occurred before and after dark. Now imagine sitting on the hood of a car, going 30 miles an hour on a treacherous road, in driving rain and 25 degree weather, for several hours over the course of several days. If you fall off the car, you are done. If you slow down too fast, you are done. If you accelerate too fast, you are done. If another car or log hits you at the right angle, you are done.

If you have ever driven an airboat, you know that Murphy's Law is alive and well and it's not uncommon for something to go wrong. And, if vou've ever driven a boat in hostile flood waters, you know that it's only a matter of time before something really bad happens. Now, if you are driving an airboat, after dark, in floodwaters, you know it's a recipe for disaster. Well, in this case, that disaster never came. Levi was the right person, in the right place, at the right time, with the right equipment, skill, and courage. None of this happened by accident, it happened because Lieutenant Krause made it happen. There was never an absence of indecision, excessive caution, or lack of confidence on his part. There was a job to do and he did it, over and over again.

Heaven forbid that any of our family members are ever in a position to be rescued or recovered. If they were, I'd want Levi and the others like him to be there. I am personally very proud of Levi's efforts and am very appreciative that this outstanding organization has stepped up to say, "Thank you, Levi".—Craig Stover, Admin, Law Enforcement, NE Game and Parks Commission.
